Thence; North 86°47'10" West, along said South Line of said Lots 21 and 22 a distance of 1318.11 feet to the Southwest Corner of said Lot 22;
Thence; North 00°58'38" East, along said West Line of said Lot 22 a distance of 674.51 feet to the Southeast Corner of the North Half of said Lot 23;
Thence; North 86°45'12" West, along said North Line a distance of 172.58 feet to the Point of Beginning.



The above described parcel of land contains 37.37 acres, more or less.
