5           **FLORIDA WATER MANAGEMENT DISTRICT APPROVING THE JULY 1,**  
6           **2012 REGULATORY PLAN AS SUMMARIZED ON THE ATTACHED**  
7           **APPENDIX A AND AUTHORIZING STAFF TO FINALIZE AND SUBMIT**  
8           **THE DETAILED 2012 REGULATORY PLAN TO THE OFFICE OF FISCAL**  
9           **ACCOUNTABILITY AND REGULATORY REFORM, IN ACCORDANCE**  
10           **WITH EXECUTIVE ORDER 11-211, AND TO THE SPEAKER OF THE**  
11           **HOUSE, PRESIDENT OF THE SENATE AND JOINT ADMINISTRATIVE**  
12           **PROCEDURES COMMITTEE, IN ACCORDANCE WITH SECTION**  
13           **120.74(3), FLORIDA STATUTES, EFFECTIVE IMMEDIATELY.**

15           **WHEREAS**, the Governor’s Executive Order 11-211 requires each agency under  
16 the direction of the Governor to submit to the Office of Fiscal Accountability and Regulatory  
17 Reform (OFARR) by July 1, 2011, and each successive year, an annual regulatory plan  
18 that identifies and describes each rule the agency expects to begin promulgating during  
19 the next twelve-month period;

20           **WHEREAS**, Section 120.74(3), Florida Statutes, requires each agency, beginning in  
21 2012, and no later than July 1 of each year, to file with the President of the Senate, the  
22 Speaker of the House of Representatives, and the Joint Administrative Procedures  
23 Committee a regulatory plan identifying and describing each rule the agency proposes to  
24 adopt for the 12-month period beginning on the July 1 reporting date and ending on the  
25 subsequent June 30, excluding emergency rules;

26           **WHEREAS**, the Office of Fiscal Accountability and Regulatory Reform has provided  
27 a detailed form that, when completed, constitutes the agency’s regulatory plan.

28           **Now Therefore,**

29           **BE IT RESOLVED BY THE GOVERNING BOARD OF THE SOUTH FLORIDA**  
30 **WATER MANAGEMENT DISTRICT:**

31           **Section 1.** The Governing Board of the South Florida Water Management District  
32 hereby approves the 2012 Regulatory Plan as summarized on the attached Appendix A.
