7 ORDER 4500006812 WITH MANPOWER TEMPORARY SERVICES AND AUTHORIZE A
8 WAIVER OF COMPETITION AS AN EXCEPTION TO THE GENERAL STANDARDS OF
9 COMPETITION, FOR A SAP HELP DESK TECHNICIAN, IN AN AMOUNT NOT TO
10 EXCEED \$187,200 FOR WHICH \$62,400 OF AD VALOREM FUNDS ARE IN THE FY10
11 BUDGET AND THE REMAINDER IS SUBJECT TO GOVERNING BOARD APPROVAL
12 OF THE FY11 - FY12 BUDGETS; PROVIDING AN EFFECTIVE DATE. (PURCHASE

15 WHEREAS, the Governing Board of the South Florida Water Management District
16 deems it necessary, appropriate, and in the public interest to authorize an amendment to
17 purchase order 4500006812 with Manpower Temporary Services and authorize a waiver
18 of competition as an exception to the general standards of competition, for a SAP Help
19 Desk Technician, in an amount not to exceed \$187,200 for which \$62,400 of ad valorem
20 funds are in the FY10 budget and the remainder is subject to Governing Board approval of
21 the FY11 - FY12 budgets; providing an effective date. (Purchase Order No. 4500006812)
