14 WHEREAS, the District is empowered to grant such releases and approvals pursuant to  
15 Section 373.096, Florida Statutes;

16 NOW THEREFORE, BE IT RESOLVED by the Governing Board of the South Florida  
17 Water Management District:

18 Section 1. The Governing Board of the South Florida Water Management District hereby  
19 approves the release of District canal reservations and TIITF canal reservations, as described in  
20 Exhibit "A", attached hereto and made a part hereof.

21 Section 2. This Resolution shall take effect immediately upon adoption.
