5 A RESOLUTION OF THE GOVERNING BOARD OF THE SOUTH FLORIDA
6 WATER MANAGEMENT DISTRICT ADOPTING AMENDMENTS TO THE
7 SFWMD FLORIDA FOREVER WORK PLAN, 2010 ANNUAL UPDATE,
8 CONTAINED IN CHAPTER 6A, VOLUME II OF THE 2010 SOUTH FLORIDA
9 ENVIRONMENTAL REPORT; PROVIDING AN EFFECTIVE DATE.

11 WHEREAS, pursuant to Section 373.199, F.S., by March 1st of each year, as part of the
12 consolidated water management annual report required by Section 373.199(7), F.S., the South Florida
13 Water Management District is required to file a yearly update of the South Florida Water Management
14 District Florida Forever Work Plan to further the goals of the Florida Forever Act and to submit the Work
15 Plan to the Secretary of the Florida Department of Environmental Protection, the Governor, the President
16 of the Florida Senate, and the Speaker of the Florida House of Representatives; and

18 WHEREAS, the South Florida Water Management District Florida Forever Work Plan, 2010
19 Annual Update is contained in Chapter 6A, Volume II of the 2010 South Florida Environmental Report;

22 WHEREAS, on December 10, 2009, the South Florida Water Management District Florida
23 Forever Work Plan, 2010 Annual Update, Chapter 6A, Volume II of the 2010 South Florida Environmental
24 Report, was presented to the Governing Board of the South Florida Water Management District adopting
25 the Work Plan 2010 Update following a public hearing held pursuant Section 373.139, F.S.; and

27 WHEREAS, District staff recommends certain amendments be made to the South Florida Water
28 Management District Florida Forever Work Plan, 2010 Annual Update, Chapter 6A, Volume II of the 2010
29 South Florida Environmental Report, to incorporate modifications necessary to make the report consistent
30 with the Five-Year Capital Improvement Plan (CIP), contained in Chapter 4, Volume II of the 2010 South
31 Florida Environmental Report.

33 NOW THEREFORE, BE IT RESOLVED by the Governing Board of the South Florida Water

37 amendments to the South Florida Water Management District Florida Forever Work Plan, 2010 Annual
