Commence at the Southeast corner of said Section 25, Township 35 South, Range 32 East;

Thence North 88°54'32" West, along the South line of said Section 25, a distance of 662.00 feet, to the Southwest corner of said Lot 32;

Thence, North 00°39'39" East, along the West line of said Lot 32, a distance of 278.34 feet to the POINT OF BEGINNING;

Thence North 47°44'44" East, departing said West line of Lot 32, a distance of 551.33 feet;

Thence North 67°50'36" East, a distance of 505.26 feet;

Thence North 86°56'59" East, a distance of 478.70 feet;

Thence North 45°31'44" East, a distance of 343.66 feet;

Thence North 52°48'50" East, a distance of 135.78 feet;

Thence North 26°52'11" East, a distance of 210.31 feet;

Thence North 02°41'24" East, a distance of 228.31 feet;

Thence North 17°28'09" East, a distance of 339.51 feet;

Thence North 09°49'10" West, a distance of 16.71 feet, to a point on the North line of the South half of said Lot 23; said Point Bears North 86°45'12" West, a distance of 172.58 feet, form the Northeast Corner of said South Half of Lot 23.

Thence North 86°45'12" West, along the North line of the South half of said Lot 23, a distance of 178.47 feet;

Thence, South 01°08'15" West, a distance of 270.46 feet;

Thence South 42°14'39" West, a distance of 788.42 feet;

Thence South 67°21'11" West, a distance of 1294.80 feet to a point on the West line of said Lot 32;

Thence, South 00°39'39" West, along the West line of said Lot 32, a distance of 323.05 feet, more or less, to the POINT OF BEGINNING.

The above described parcel of land contains 11.25 acres, more or less.

The bearings shown hereon are based on the Florida State Plane Coordinate System, East Zone, North American Datum of 1983, and further based on the South line of said Section 25, said line bears North 88°54'32" West and all bearings are relative hereto.


