RESOLUTION NO. 2010-**

A RESOLUTION OF THE GOVERNING BOARD OF THE SOUTH FLORIDA WATER MANAGEMENT DISTRICT TO AUTHORIZE ENTERING INTO A THREE YEAR WORK ORDER CONTRACT, SUBJECT TO SUCCESSFUL NEGOTIATIONS WITH LABORATORY DATA CONSULTANTS FL, INC., ONE OF FOUR FIRMS SELECTED UNDER REQUEST FOR PROPOSAL 600000307 FOR QUALITY ASSURANCE/QUALITY CONTROL AND VALIDATION OF SCIENTIFIC PROCESSES AND DATA (INCLUDING FIELD SAMPLING AND LABORATORY AUDITS, REVIEW OF FIELD AND LAB STANDARD OPERATING PROCEDURES, ETHICS TRAINING), IN AN AMOUNT NOT TO EXCEED THE TOTAL FUNDING OF \$900,000 FOR ALL FOUR CONTRACTS (4600002056, 4600002057, 4600002058, AND 4600002059), FOR WHICH \$300,000 IN AD VALOREM AND DEDICATED FUNDS ARE SUBJECT TO GOVERNING BOARD APPROVAL OF THE FY11 BUDGET; AND THE REMAINDER IS SUBJECT TO GOVERNING BOARD APPROVAL OF THE FY12-13 BUDGETS; PROVIDING AN EFFECTIVE DATE. (CONTRACT NUMBER 4600002059) (MICHAEL WRIGHT, EXT. 4523)

WHEREAS, the Governing Board of the South Florida Water Management District deems it necessary, appropriate and in the public interest to authorize entering into a three year work order contract, subject to successful negotiations with Laboratory Data Consultants FL, Inc., one of four firms selected under Request for Proposal 600000307 for Quality Assurance/Quality Control and Validation of Scientific Processes and Data (including field sampling and laboratory audits, review of field and lab Standard Operating Procedures, ethics training), in an amount not to exceed the total funding of \$900,000 for all four contracts (4600002056, 4600002057, 4600002058, and 4600002059), for which \$300,000 in ad valorem and dedicated funds are subject to Governing Board approval of the FY11 budget; and the remainder is subject to Governing Board approval of the FY12-13 budgets; providing an effective date. (Contract Number 4600002059) (Michael Wright, ext. 4523) and;

NOW THEREFORE, BE IT RESOLVED by the Governing Board of the South Florida Water Management District:

Section 1. The Governing Board of the South Florida Water Management District hereby authorizes the execution of 4600002059 with Laboratory Data Consultants FL, Inc.

Section 2. This resolution shall take effect immediately upon adoption.
