COMMENCE AT THE NORTHWEST CORNER OF SAID NORTH ONE-QUARTER (N 1/4), OF THE NORTHWEST ONE-QUARTER (NW 1/4) OF SECTION 12; THENCE, SOUTH 0°36'41" EAST ALONG THE WEST LINE OF SAID NORTH ONE-QUARTER (N 1/4), NORTHWEST ONE-QUARTER (NW 1/4) OF SECTION 12, A DISTANCE OF 481.44 FEET TO THE NORTHERLY LINE OF SAID 175 FOOT STRIP; THENCE, SOUTH 0°36'41" EAST CONTINUING ALONG SAID WEST LINE, A DISTANCE OF 180.06 FEET TO THE SOUTHERLY LINE OF SAID 175 FOOT STRIP OF LAND; THENCE, NORTH 75°45'49" EAST ALONG SAID SOUTHERLY LINE, A DISTANCE OF 635.00 FEET TO THE POINT OF BEGINNING; THENCE, CONTINUE NORTH 75°45'49" EAST, ALONG SAID SOUTHERLY LINE, A DISTANCE OF 676.44 FEET; THENCE, NORTH 1°46'54" WEST, A DISTANCE OF 179.22 FEET TO THE NORTHERLY LINE OF SAID 175 FOOT STRIP OF LAND; THENCE, SOUTH 75°45'49" WEST, ALONG SAID NORTHERLY LINE, A DISTANCE OF 715.09 FEET; THENCE, SOUTH 14°14'11" EAST, A DISTANCE OF 175.00 FEET TO THE POINT OF BEGINNING.


