Thence, North 05°29'29" East, a distance of 361.57 feet;

Thence, North 77°14'02" West, a distance of 85.13 feet;

Thence, South 59°22'22" East, a distance of 81.20 feet, to a point on the East line of said Lot 17 and the East line of said Section 30;  
Thence, North 00°51'44" East, along the East line of said Lot 17 and the East line of said Section 30, a distance of 258.36 feet to a Point, said Point bears South 00°51'44" West, a distance of 565.51 feet from the Northeast Corner of said Lot 17;  
Thence, North 63°04'35" West, a distance of 36.14 feet;  
Thence, North 48°32'51" West, a distance of 557.59 feet;  
Thence, North 08°15'42" West, a distance of 210.15 feet to a point on the North line of said Lot 17 and the North line of the South half of said Section 30, said Point bears North 86°43'14" West, a distance of 489.65 feet from the Northeast Corner of said Lot 17;  
Thence, North 86°43'14" West, along the North line of said Lot 17 and the North line of the South half of said Section 30, a distance of 57.75 feet to the POINT OF BEGINNING of Parcel 3.

Said Parcel 3 containing 5.36 acres, more or less.


The above three parcels of land contains 20.12 acres, more or less.
