A RESOLUTION OF THE GOVERNING BOARD OF THE SOUTH FLORIDA WATER MANAGEMENT DISTRICT APPROVING RELEASE OF CANAL AND ROAD RESERVATIONS, ISSUANCE OF A NON-USE COMMITMENT AS TO MINERAL RESERVATION, AND ISSUANCE OF AN APPROVAL OF RELEASE OF CANAL RESERVATION, CONTAINING 16.89 ACRES, MORE OR LESS, PARCELS A, B, AND C, LAKEVIEW SQUARE, PLAT BOOK 146, PAGE 37, SECTION 31, TOWNSHIP 48 SOUTH, RANGE 41 EAST, BROWARD COUNTY, FLORIDA; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the underlying landowner, Coral Baptist Church, Inc., a Florida non-profit corporation, has requested that the South Florida Water Management District (the "District") release canal and road reservations and issue a non-use commitment as to the mineral reservation, reserved under EDD Deed No. 1616, E-DDD 583, and TIIF Deed No. 2057, held by the District, as successor to the Everglades Drainage District, and issue an approval to the Trustees of the Internal Improvement Trust Fund (the "Trustees") regarding release of canal reservations reserved under TIITF Deed No. 16198, held by the Trustees;

WHEREAS, the District is empowered to grant such releases pursuant to Section 373.096, Florida Statutes;

NOW THEREFORE, BE IT RESOLVED by the Governing Board of the South Florida Water Management District:

Section 1. The Governing Board of the South Florida Water Management District hereby approves the release of canal and road reservations, and the issuance of a non-use commitment as to the mineral reservation, all being reserved by the Everglades Drainage District under E-EDD Deed No. 583, EDD Deed No. 1616, and TIIF Deed No. 2057, and issuance of an approval to the Trustees of the Internal Improvement Trust Fund regarding canal reservation reserved under TIITF Deed No. 16198, containing 16.89 acres, more or less, Parcels A, B and C, LAKEVIEW SQUARE Plat Book 146, Page 37, Section 31, Township 48 South, Range 41 East, Broward County, Florida.

Section 2. This Resolution shall take effect immediately upon adoption.
