

#### SURVEYOR'S REPORT

#### BENCHMARK AND WELL "STL 269"

- 1. Elevations shown herein are referenced to the North American Vertical Datum of 1988 (NAVD88) and are in represented in U.S. Survey Feet.
- Elevations represented as NGVD 1929 (National Geodetic Vertical Datum of 1929) were determined from either the superceded values given on the NGS Datasheet downloaded from the NGS website or were determined using the "NGVD29.TXT" file. Vertcon <u>was not</u> used to transform NAVD88 elevations to NGVD29 values.
- 3. A Second Order Class II level run was performed to bring vertical control to newly constructed benchmarks at or near the specific well site. The data for level run is being submitted to NGS in "Blue-Book" format so that it will be included into the NGS database. Newly constructed benchmarks meet the NGS guidelines for a "Stability C" monument and have a SFWMD Survey Marker set in them.
- 4. A 3 wire third order leveling was performed between the established benchmark and the existing well.
- 5. Vertical Control used for this Benchmark and Well are as follows:
