How to Reach

Description

TO REACH: FROM THE INTERSECTION OF PLEASANT HILL ROAD AND SOUTHPORT ROAD IN OSCEOLA COUNTY, FLORIDA, GO SOUTHWEST FOR 0.5 MILE TO THE INTERSECTION OF PLEASANT HILL ROAD WITH OLD PLEASANT HILL ROAD; TURN LEFT ONTO OLD PLEASANT HILL ROAD AND GO 0.6 MILE TO THE INTERSECTION OF SCRUB JAY TRAIL WITH OLD PLEASANT HILL ROAD; TURN LEFT ON SCRUB JAY TRAIL, WHICH IS THE ENTRANCE TO THE DISNEY WILDERNESS PRESERVE, AND GO 0.4 MILE TO THE FIRST DIRT ROAD GOING RIGHT; TURN RIGHT AND GO SOUTH ON THE DIRT ROAD FOR ABOUT 0.05 MILE TO A GATE AND CONTINUE SOUTH ON THE DIRT ROAD FOR ANOTHER 6.5 MILES TO THE STATION ON THE RIGHT. BENCH MARK WRWX IS APPROXIMATELY



250 FEET WEST OF THE DIRT ROAD.

NOTABLE LAND MARKS: BENCH MARK WRWX IS SITUATE ON THE SFWMD WELL SITE DESIGNATED WRWX, AND LIES ABOUT 5 FEET SOUTHEAST OF THE MIDPOINT OF THE SOUTHEAST SIDE OF A 4 TALL BARB WIRE FENCE SURROUNDING THE FOUR WELLS AT THE WRWX SITE.
