SURVEY REPORT

Background:

Under Work Order No. 4600003011-WO01, Arcadis performed a Boundary and Topographic Survey of the former Mecca Farms property. The survey commenced in June, 2015 and was completed in October 2015. Horizontal and Vertical Control was established throughout the 1647.84 acre project site. 3rd Order levels were run from existing published NGS Benchmarks with temporary site control benchmarks set at various intervals within the project. All levels began at a published NGS benchmark and closed on another published NGS benchmark. A Leica NA2 optical level was used for all leveling work.

Procedures and Data Collection:

One Permanent Benchmark was set at each of the eight Groundwater Monitoring Well clusters. Each benchmark consisted of a one and one-quarter inch diameter galvanized steel pipe, driven to a depth of five feet and set in a 12 inch diameter, 24 inch deep concrete collar. A standard SFWMD aluminum disk was set in the top of the pipe and stamped with the well cluster ID and 2016. A Carsonite Witness post was set approximately 2 feet from each benchmark.

3rd order levels were run to each new benchmark from either a published NGS benchmark or benchmarks set in the previously established level network. Each level run was checked by closing back to a published National Geodetic Survey Benchmark (NGS) or project network benchmark. A Leica NA2 optical level was used for all elevation work. All level runs meet or exceed 0.03 feet √miles (0.03-feet times the square root of the distance in miles. Elevations are NAVD 88 Datum. The following NGS Benchmarks were run through for this survey: T 537, U 537, V 537, W 537, X 537, Y 537, S 547 and T 547. NGS Benchmark X 537, elevation 23.29 NAVD was held for MFEB1, MFEB2, MFEB3, MFEB4, MFEB5 and MFEB6. NGS Benchmark S 547, elevation 20.00 was held for MFEB7. NGS Benchmark T 537, elevation 19.16 was held for MFEB8

State Plane Coordinates for each benchmark are NAD 83, 2011 Adjustment and were obtained by Rapid Static GPS observations, minimum 20 minutes observation time. Post processing by NGS OPUS Processing Service.

The location and elevations were obtained for each of the 24 Groundwater Monitoring Wells. The location was obtained by Real Time Kinematic GPS observations. NGS Monument C 18 S was held for coordinate values. The following elevations were taken for each of the 24 wells: Top of aluminum flange of riser on north side, north top of 2" PVC well casing, north edge of water level sensor sleeve and ground elevation next to each well. Groundwater elevations were obtained from the data collected for each electronic water level sensor. The date of for the groundwater elevation is noted on the individual Well Data sheets.

Photographs were taken for each Groundwater Monitoring Well and Benchmark. Well photographs

were taken: One looking down at the open well, one looking down at the open well with tape measure, one oblique photograph from 3 feet away and one oblique photograph from 10 feet away. Benchmark photographs were taken: One looking down at the benchmark, one oblique photograph from 5 feet away and one oblique photograph from 15-20 feet away.

The field work began February 10, 2016 and was completed on May 4, 2016.
